 2. Enclosure around well / water filtration system - filtration system must be removed within 7 days from Drainage Easement - fees due
 3. Haring - new home construction plan submitted to ARC. [Tabled pending permitting.](#)
- Harbaugh - 16730 Oak Grove: Solar project - ready permits issued. Ready to start project in late December, 2024
